D.C. CARE CONSORTIUM RECOGNITION RESOLUTION OF 1995

WHEREAS, THE D.C. CARE CONSORTIUM WAS FORMED ON JUNE 19, 1991, IN RESPONSE TO TITLE 11 OF THE RYAN WHITE EMERGENCY CARE ACT OF 1990:

WHEREAS, THE D.C. CARE CONSORTIUM PROVIDES STRATEGIC PLANNING, TECHNICAL ASSISTANCE, AND COORDINATION OF HIV/AIDS SERVICES FOR MORE THAN 60 MEMBER ORGANIZATIONS IN THE DISTRICT OF COLUMBIA;

WHEREAS, THE D.C. CARE CONSORTIUM MEMBERSHIP COVERS THE FULL SPECTRUM OF SERVICES BEING PROVIDED TO PEOPLE INFECTED WITH HIV AND THOSE LIVING WITH AIDS;

WHEREAS, THE D.C. CARE CONSORTIUM ADMINISTERS THE HIV HOUSING COORDINATION PROGRAM AND THE CAPITAL RESEARCH NETWORK, A HIV CLINICAL TRIALS REFERRALS SERVICES;

WHEREAS, THE D.C. CARE CONSORTIUM PROVIDES FAMILY CENTERED CARE AND ENHANCED CASE MANAGEMENT SERVICES THROUGH SUBCONTRACTS WITH MEMBER ORGANIZATIONS; AND

WHEREAS, THE D.C. CARE CONSORTIUM PROVIDES A FORUM FOR SERVICE PROVIDERS TO PLAN, COORDINATE, NETWORK, AND ADVOCATE FOR POLICIES, FUNDING, AND PROGRAMS TO FULFILL THE NEEDS OF THE DIVERSE POPULATION OF PERSONS LIVING WITH HIV AND AIDS IN THE DISTRICT OF COLUMBIA;

RESOLVED, BY THE DISTRICT OF COLUMBIA, THAT THIS RESOLUTION MAY BE CITED AS THE "D.C. CARE CONSORTIUM RECOGNITION RESOLUTION OF 1995".

SEC. 2. THE COUNCIL OF THE DISTRICT OF COLUMBIA RECOGNIZES AND HONORS THE CONTRIBUTIONS AND DEDIGATION OF D.C. CARE CONSORTIUM, ITS STAFF, VOLUNTEERS, AND MEMBER ORGANIZATIONS AND PROFESSIONALS PROVIDING SERVICES TO PEOPLE LIVING WITH THE HIV INFECTION AND THOSE LIVING WITH AIDS.
